

**PART 6**  
**SNOW AND ICE EMERGENCY**

**§ 15-601. Declaration of Snow and Ice Emergency. [Ord. 1-1991, 8/5/1991; as amended by Ord. 7-2014, 11/17/2014]**

In order to facilitate the movement of traffic and to combat the hazards of snow and ice on the snow emergency routes named in § 15-603 of this Part 6, the Township Road Supervisor in consultation with at least one Township Supervisor, in their discretion, may declare a snow and ice emergency (designated in this part as a "snow emergency"). Information on the existence of the snow emergency may be given by the Township by radio, newspaper or other available media, and information on the termination of the snow emergency may be given by use of the same media. The declaration of a snow emergency shall specifically state a time and date as to when the snow emergency shall take effect and be deemed to have been declared by the Township.

**§ 15-602. Parking Prohibited, Driving of Motor Vehicles Restricted, on Snow Emergency Routes During Emergency. [Ord. 1-1991, 8/5/1991]**

After any snow emergency is declared, it shall be unlawful, at any time during the continuance of the emergency, for any person:

1. To park a motor vehicle or to allow that vehicle to remain parked anywhere on any snow emergency route designated in § 15-603 of this Part 6; or
2. To drive any motor vehicle on any such snow emergency route, unless that vehicle is equipped with snow tires or chains.

**§ 15-603. Snow Emergency Routes Designated. [Ord. 1-1991, 8/5/1991; as amended by Ord. 7-2014, 11/17/2014]**

The following are designated as snow emergency routes:

Beverly Drive	Ladybug Lane & Katy Lane
Butterfly Drive	Cricket Lane & Ladybug Lane
Cricket Lane	Kutztown Road & Stracks Dam Road
Firefly Drive	Ladybug Lane & Houtztown Road
Franklin Avenue	North Locust Avenue & Good Will Avenue
Jackson Avenue	North Locust Avenue & Good Will Avenue
Katy Lane	Beverly Drive & Houtztown Road
Ladybug Lane	Cricket Lane & Beverly Drive

**§ 15-604. Penalty for Violation. [Ord. 1-1991, 8/5/1991; as amended by Ord. 7-2014, 11/17/2014]**

1. If, at any time during a snow emergency declared under § 15-601 of this Part 6, a person shall park a motor vehicle or allow a motor vehicle to remain parked anywhere upon a snow emergency route, that person shall be guilty of a violation of this Part 6, and, upon conviction, shall be sentenced to pay a fine of not more than \$50 and costs.
2. If, at any time during a period of snow emergency declared under § 15-601 of this Part 6, a person shall drive a motor vehicle upon a snow emergency route, without having that vehicle equipped with snow tires or chains, that person shall be guilty of a violation of this Part 6, and, upon conviction, shall be sentenced to pay a fine of not more than \$75 and costs.
3. If, at any time after a declared snow emergency is deemed to take effect, any person or entity leaves a motor vehicle on a snow emergency route identified under § 15-603 while a snow emergency is deemed to be in effect, said vehicle shall be subject to towing by the Township and/or the Township's agent at the owner's expense.
